Article 1: Introduction

This is the Privacy Statement of LoveIsWhatWeAre.com. In this statement you can read how I treat the personal data that I receive when making contact with you.

LoveIsWhatWeAre.com complies with the requirements of the General Data Protection Regulation (GDPR).

Article 2: Collection of personal data

Your privacy is very important to me. I will do my utmost to protect your data. In order to provide you with services and to guarantee my service to you, I will need some of your personal data. LoveIsWhatWeAre.com processes this data because you use my services and/or because you have provided me with this data yourself.

I use this data for the following purposes:

- To carry out your order and to inform you about the order process;
- To provide you with information.

Article 3: Third parties

LoveIsWhatWeAre.com shall never provide your data to third parties.

Article 4: Minors

LoveIsWhatWeAre.com does not intend to collect data from persons who are younger than 18. Therefore, I do not provide services to minors. I advise parents to become involved in the online activities of their children, in order to prevent data on children being collected without parental consent. If you are convinced that I have collected personal data on minors without this consent, please contact me. In that case, I will delete this information.

Article 5: Security

For the transmission of data I use the so-called SSL security system (Secure Socket Layer) in connection to a 128/256 Bit encryption. This technique provides the most secure connection, and is therefore also used for example by banks for the protection of data protection in online banking. All proofs of payment provided by me are protected extensively by the aforementioned standard. You can be certain that your data is encrypted before transmission by the key icon or closed lock icon in the status bar of your browser.

Article 6: Website visit data

I do not receive any data on your visit to my website, such as cookies.

Article 7: Reviewal and correction of data

You may review the personal data you have provided me with whenever you wish to.

Article 8: Retention period of data and reviewal

When you have received an order, I shall delete the data provided that I needed to process your order.

You have the right to review the data that I have received from you when you place orders. You may file a request for reviewal, correction or deletion via my contact page. To be certain that this reviewal request has been made by you, I ask you to send a copy of your ID along with your request. In order to protect your privacy, we request you to blur your photo and social security number with a black pen. LoveIsWhatWeAre.com will respond to your request as soon as possible, and within four weeks.

Article 9: Complaints

If you have a complaint about the processing of your personal data, I request you to contact me via my contact page. In the event that you believe that the complaint about the processing of your personal data has not been dealt with appropriately, you can take this up with the designated regulatory authority.

Article 10: Alterations

I reserve the right to alter this privacy statement. It is therefore advised that you consult this statement regularly to remain informed of such alterations.
